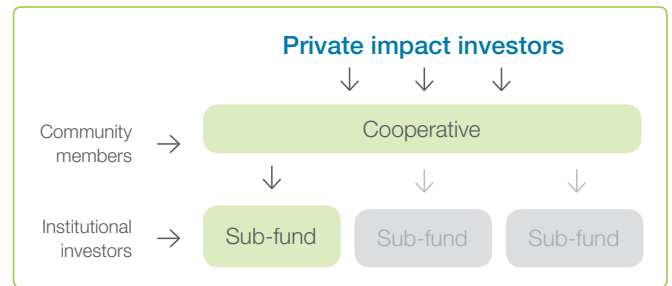

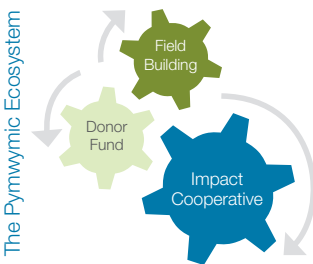
## PYMWYMIC ONLINE
